

# CONTEST RULES

1. Each challenge runs from the date the applicable post is published until 100 likes have been reached on that post, after which point the challenge will be closed. The winning participants for each challenge will be chosen and notified by the Achieve Anything Foundation (AAF) within 48 hours of the post reaching 100 likes. Should the applicable post fail to meet the target 100 likes by 12:00 Noon PDT April 23, 2023, the challenge will become null and void.
2. The post targets and official time will be monitored by designated AAF staff located in British Columbia, CANADA. Entries submitted after the post target has been reached, or after 12:00 Noon PDT Sunday April 23, 2023 are ineligible, null, and void. AAF is not responsible for any entries that are not received for any reason by the close of the contest.
3. To enter, like and/or comment on the contest post.
4. The winner will be chosen by random draw from post likes and comments, so long as the participant satisfies the contest eligibility requirements and complies with these contest rules.
5. To be eligible to participate in the contest, a participant must be at least 19 years old; and, must be a resident of either Canada or the U.S. AAF employees and directors are not eligible to win. The winning participant may be required to sign an affidavit of eligibility to receive the prize.

If that participant does not email AAF within 48 hours after AAF announces and contacts the participant, that participant forfeits the prize, and the prize will be offered to the next place participant.
